

UT Health San Antonio Greehey Campus Construction Parking Transition

Executive Summary

UT Health San Antonio is on a rapid growth trajectory that will result in the construction of several new structures on the Greehey Campus. Among them are the UT Health San Antonio Multispecialty and Research Hospital, a six-story employee parking garage, and a building dedicated to brain health and research. During construction, tentatively scheduled to begin in November, adjustments to parking services and operations will be necessary.

At this time, approximately 320 faculty, students, and staff who park in the following lots will be relocated due to the construction.

Lot 24 – Center for Oral Health Care and Research (COHCR), starting Jan. 3, 2023

Lot 34 – Barshop, starting around Feb. 2, 2023

Lot 31 - Medical Arts and Research Center (MARC), starting March 31, 2023

Lots 16, 17, 23, 30, and Garages C and E will be utilized for relocation (Appendix A). Dates are provided by the Office of Capital Projects (OCP) and construction companies; however, construction start dates are subject to change which may impact communication release dates.

If individuals are relocated, parking fees will be adjusted to the appropriate zone. Individuals with reserved parking impacted by the construction will be contacted directly as soon as more information is available. Plans for a shuttle service from Lot 17 to the Center for Oral Health Care and Research and the Medical Arts and Research Center are also in development. UT Health Parking Services has communicated to and is working with MARC, COHCR, and Barshop management teams in preparation of the anticipated moves.

Parking & Transportation Communication Plan

The communication plan generally identifies dates and methods of communication to be utilized and, more specifically, communications with impacted reserve space holders. The communication plan will be broad spectrum to include UT Health Newsroom, UT Police/UT Parking Services website, DynaSigns, print flyer distribution, student/employee listserv, and strategically placed fixed signage. For example, flyers will be placed in employee breakrooms, in elevators, and in COHCR/MARC employee crossings. UT Parking Services will also setup temporary remote workstations at impacted facilities to assist those affected by the parking relocation.




